Duane made a motion to approve Accounts Payable Checks from 71745 thru 71793. Mike seconded the motion. The motion carried by unanimous vote.


Chuck made a motion to approve add and abates from 2024000125, 2024000135 thru 2024000140. Duane seconded the motion. The motion carried by unanimous vote.

Mike made a motion to adjourn at 1:52 pm. Chuck seconded the motion. The motion carried by unanimous vote.


